


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=59) is 96% Stable, 4% Unstable. Permanent Housing Facilities (n=33) is 100% Stable. Transitional/Short Term Housing Facilities (n=90) is 51% Stable, 11% Temporary, 38% Unstable. STRMU (n=105) is 83% Stable, 12% Temporary, 5% Unstable. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




