


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=78) is 97% Stable, 3% Unstable. Permanent Housing Facilities (n=29) is 93% Stable, 7% Unstable. STRMU (n=375) is 1% Stable, 99% Temporary. This Grantee did not provide: Transitional /Short Term Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




