


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=38) is 97% Stable, 3% Unstable. Permanent Housing Facilities (n=26) is 89% Stable, 11% Temporary. Transitional/Short Term Housing Facilities (n=19) is 100% Stable. This Grantee did not provide: Transitional /Short Term Housing, STRMU. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




