




Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=94) is 94% Stable, 1% Temporary, 5% Unstable. Permanent Housing Facilities (n=10) is 100% Stable. Transitional/Short Term Housing Facilities (n=56) is 81% Stable, 1% Temporary, 18% Unstable. STRMU (n=102) is 87% Stable, 13% Temporary. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




