


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=31) is 93% Stable, 3% Temporary, 4% Unstable. STRMU (n=156) is 39% Stable, 60% Temporary, 1% Unstable. This Grantee did not provide: Permanent Housing, Transitional/Short Term Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




