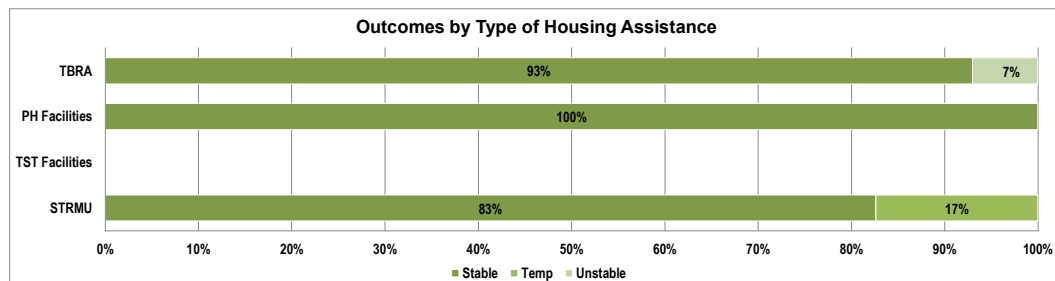

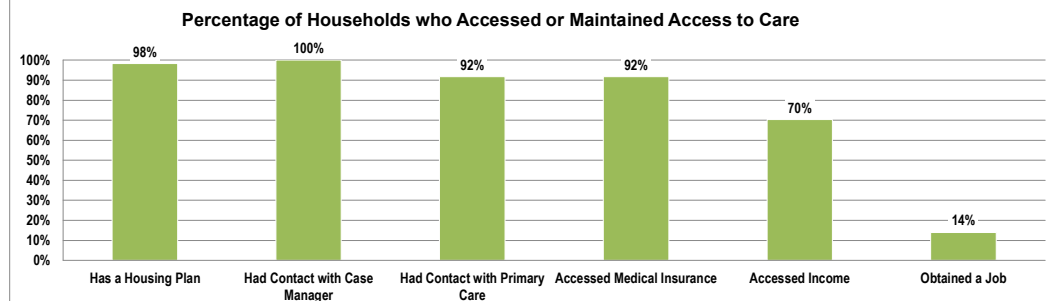

Outcomes



Outcomes by Type of Housing Assistance: TBRA (n=57) is 93% Stable, 7% Unstable. Permanent Housing Facilities (n=11) is 100% Stable. STRMU (n=69) is 83% Stable, 17% Temporary. This Grantee did not provide: Transitional /Short Term Housing. Outcomes do not include households where head of household died during operating year.

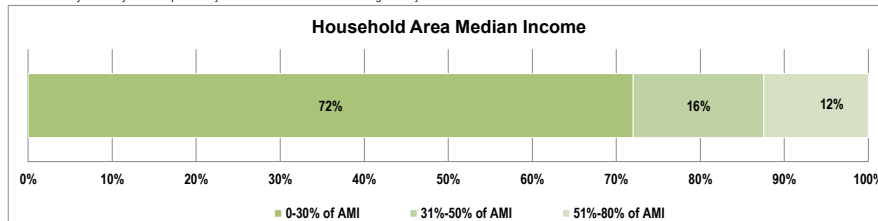

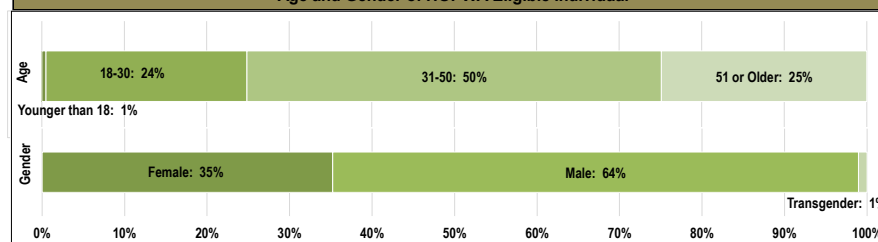

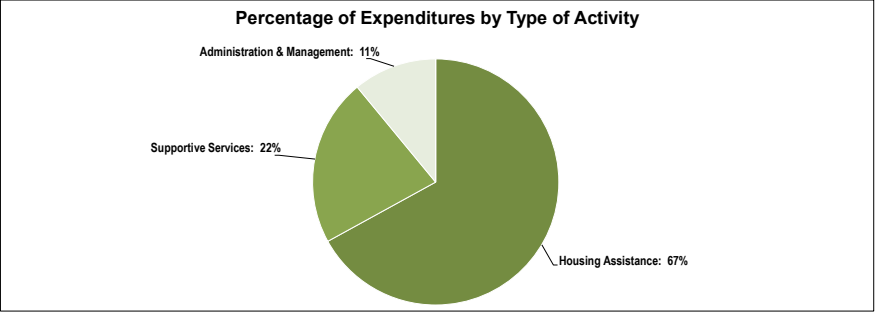
Age and Gender of HOPWA Eligible Individual



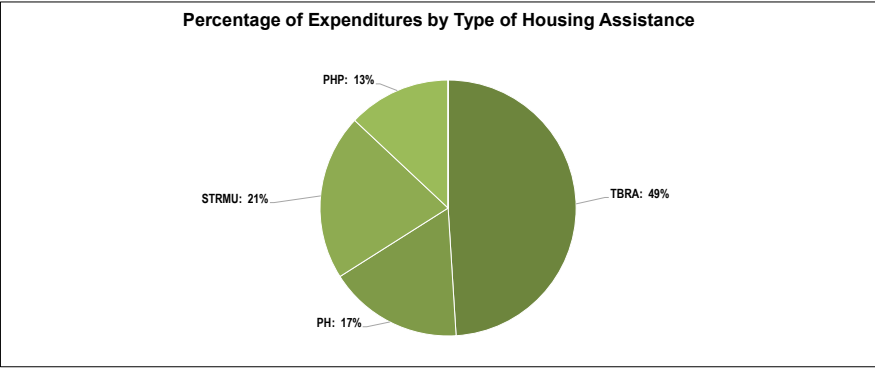

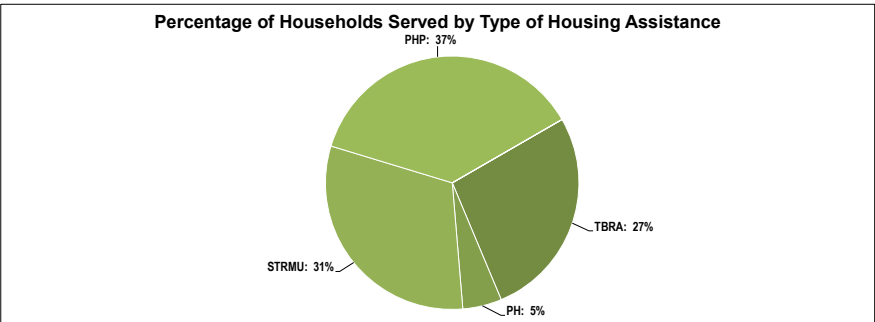
