



Outcomes



Outcomes by Type of Housing Assistance: TBRA (n=74) is 100% Stable. Permanent Housing Facilities (n=10) is 100% Stable. STRMU (n=129) is 20% Stable, 80% Temporary. This Grantee did not provide: Transitional /Short Term Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




