




Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=53) is 100% Stable. Permanent Housing Facilities (n=9) is 66% Stable, 34% Unstable. STRMU (n=136) is 3% Stable, 94% Temporary, 3% Unstable. This Grantee did not provide: Transitional /Short Term Housing. Outcomes do not include households where head of household died during operating year.





Percentage of Expenditures by Type of Activity




