




Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=219) is 96% Stable, 4% Unstable. Transitional/Short Term Housing Facilities (n=36) is 84% Stable, 2% Temporary, 14% Unstable. This Grantee did not provide: Permanent Housing, STRMU. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




