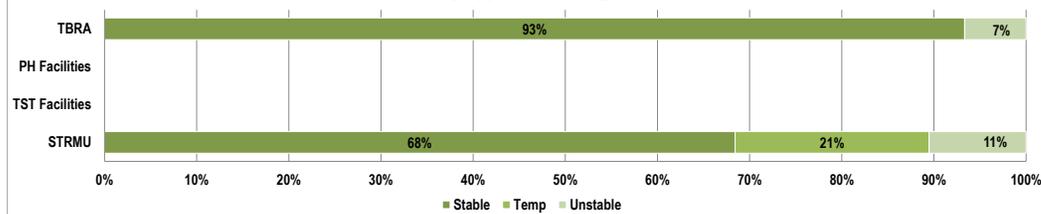

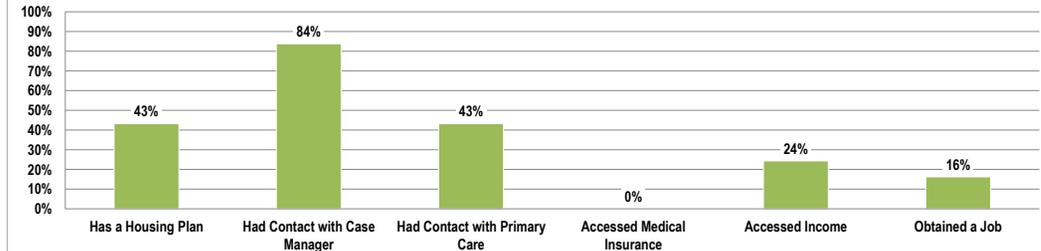
Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=15) is 93% Stable, 7% Unstable. STRMU (n=19) is 68% Stable, 21% Temporary, 11% Unstable. 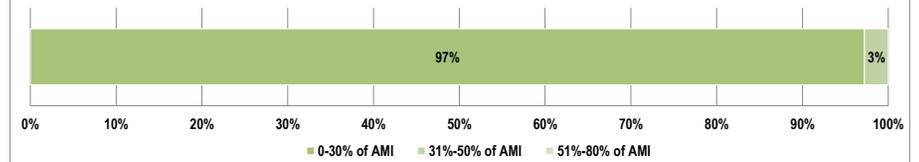

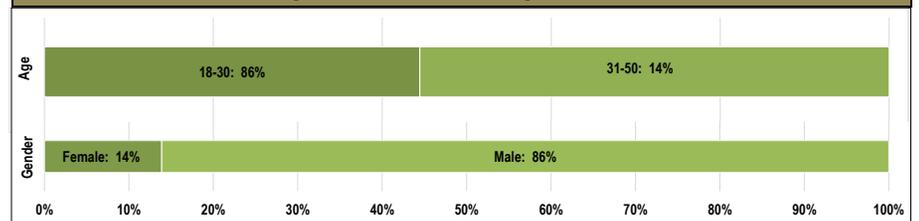

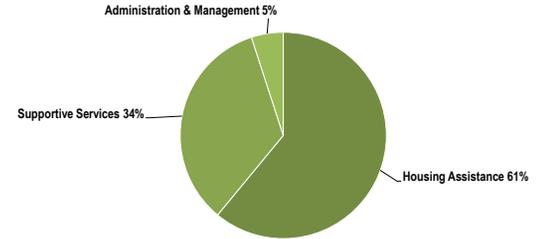

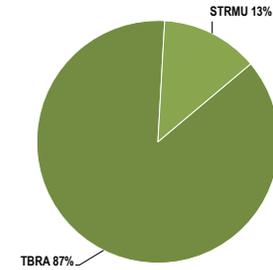

Percentage of Expenditures by Type of Activity



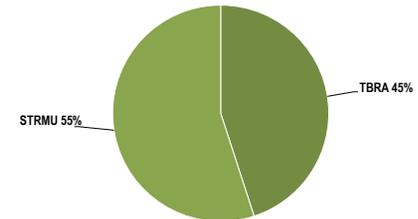
