


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=227) is 94% Stable, 6% Unstable. Permanent Housing Facilities (n=97) is 89% Stable, 1% Temporary, 10% Unstable. Transitional/Short Term Housing Facilities (n=124) is 31% Stable, 31% Temporary, 38% Unstable. STRMU (n=124) is 13% Stable, 81% Temporary, 6% Unstable. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




