


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=107) is 90% Stable, 5% Temporary, 5% Unstable. STRMU (n=425) is 93% Stable, 7% Temporary. 







Percentage of Expenditures by Type of Activity




