


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=136) is 95% Stable, 4% Temporary, 1% Unstable. Permanent Housing Facilities (n=20) is 100% Stable. Transitional/Short Term Housing Facilities (n=46) is 52% Stable, 11% Temporary, 37% Unstable. STRMU (n=74) is 87% Stable, 13% Temporary. Outcomes do not include households where head of household died during operating year.







Percentage of Expenditures by Type of Activity




