




Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=38) is 100% Stable. Transitional/Short Term Housing Facilities (n=12) is 100% Stable. STRMU (n=141) is 62% Stable, 24% Temporary, 14% Unstable. 







Percentage of Expenditures by Type of Activity




