




Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=162) is 98% Stable, 2% Unstable. Permanent Housing Facilities (n=20) is 95% Stable, 5% Temporary. Transitional/Short Term Housing Facilities (n=55) is 25% Stable, 38% Temporary, 37% Unstable. STRMU (n=277) is 7% Stable, 93% Temporary. Outcomes do not include households where head of household died during operating year.








Number of Dependents under Age of 18 Residing with the HOPWA Eligible Individual


