


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=89) is 96% Stable, 4% Unstable. Transitional/Short Term Housing Facilities (n=169) is 74% Stable, 9% Temporary, 17% Unstable. STRMU (n=139) is 57% Stable, 43% Temporary. This Grantee did not provide: Permanent Housing. Outcomes do not include households where head of household died during operating year.







Percentage of Expenditures by Type of Activity




