


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=438) is 98% Stable, 1% Temporary, 1% Unstable. Permanent Housing Facilities (n=2409) is 99% Stable, 0% Temporary, 1% Unstable. STRMU (n=13) is 100% Stable Temporary. This Grantee did not provide: Transitional/Short Term Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




