


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=402) is 99% Stable, 1% Unstable. Permanent Housing Facilities (n=2484) is 98% Stable, 1% Temporary, 1% Unstable. STRMU (n=12) is 100% Stable. This Grantee did not provide: Transitional /Short Term Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




