




Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: Permanent Housing Facilities (n=22) is 100% Stable. Transitional/Short Term Housing Facilities (n=135) is 92% Stable, 2% Temporary, 6% Unstable. STRMU (n=84) is 29% Stable, 69% Temporary, 2% Unstable. This Grantee did not provide: TBRA. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




