


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=147) is 88% Stable, 5% Temporary, 7% Unstable. Transitional/Short Term Housing Facilities (n=196) is 53% Stable, 16% Temporary, 31% Unstable. STRMU (n=413) is 73% Stable, 20% Temporary, 7% Unstable. This Grantee did not provide: Permanent Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




