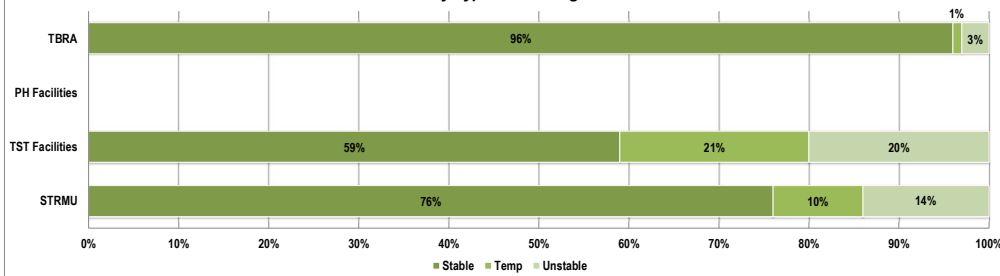

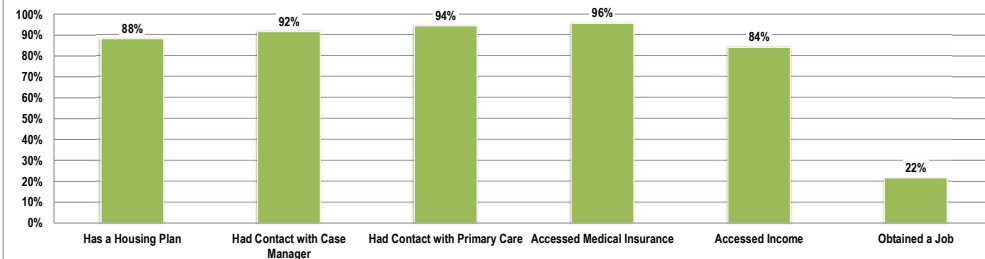
Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=118) is 96% Stable, 1% Temporary, 3% Unstable. Transitional/Short Term Housing Facilities (n=140) is 59% Stable, 21% Temporary, 20% Unstable. STRMU (n=330) is 76% Stable, 10% Temporary, 14% Unstable. This Grantee did not provide: Permanent Housing. Outcomes do not include households where head of household died during operating year.

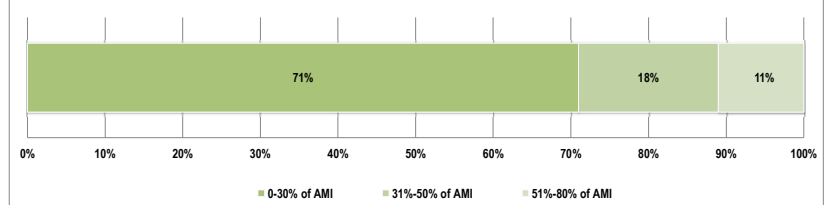

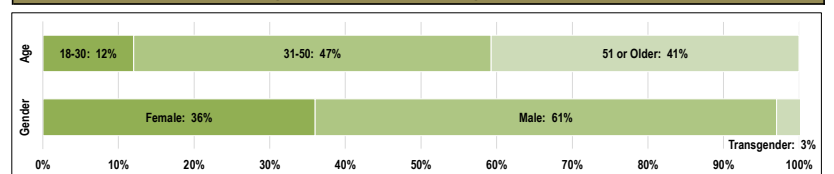

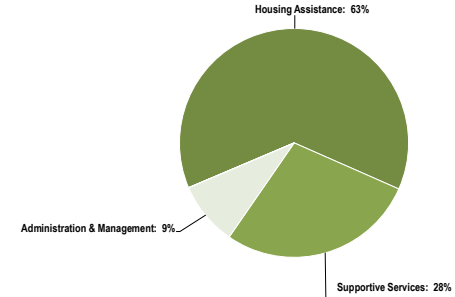

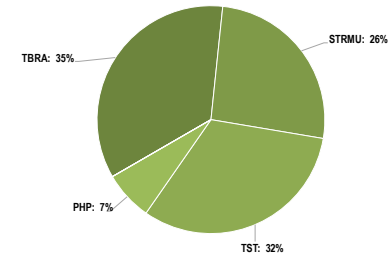

Percentage of Expenditures by Type of Activity



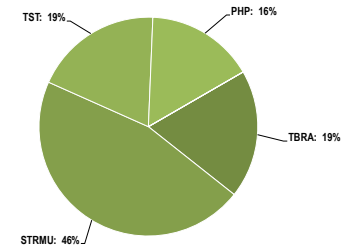
