


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=568) is 99% Stable, 0% Temporary, 1% Unstable. Permanent Housing Facilities (n=31) is 96% Stable, 4% Unstable. STRMU (n=6) is 67% Stable, 33% Temporary. This Grantee did not provide: Transitional /Short Term Housing. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




