




Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=56) is 97% Stable, 3% Temporary. Permanent Housing Facilities (n=62) is 97% Stable, 3% Temporary. Transitional/Short Term Housing Facilities (n=4) is 50% Stable, 25% Temporary, 25% Unstable. STRMU (n=94) is 86% Stable, 14% Temporary. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




