


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=171) is 99% Stable, 1% Unstable. Permanent Housing Facilities (n=32) is 100% Stable. Transitional/Short Term Housing Facilities (n=11) is 90% Stable, 10% Unstable. STRMU (n=187) is 100% Stable Temporary. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




