




Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=196) is 100% Stable. Permanent Housing Facilities (n=213) is 97% Stable, 1% Temporary, 2% Unstable. Transitional/Short Term Housing Facilities (n=20) is 90% Stable, 10% Temporary. STRMU (n=86) is 42% Stable, 58% Temporary. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




