


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=69) is 97% Stable, 3% Unstable. Permanent Housing Facilities (n=111) is 99% Stable, 1% Unstable. STRMU (n=70) is 64% Stable, 36% Temporary. This Grantee did not provide: Transitional /Short Term Housing. Outcomes do not include households where head of household died during operating year.







Percentage of Expenditures by Type of Activity




