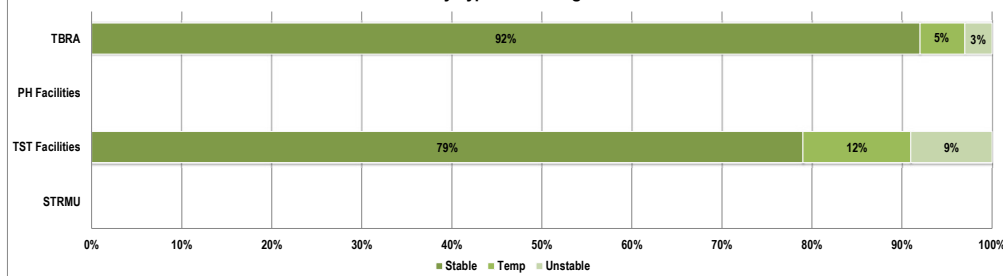

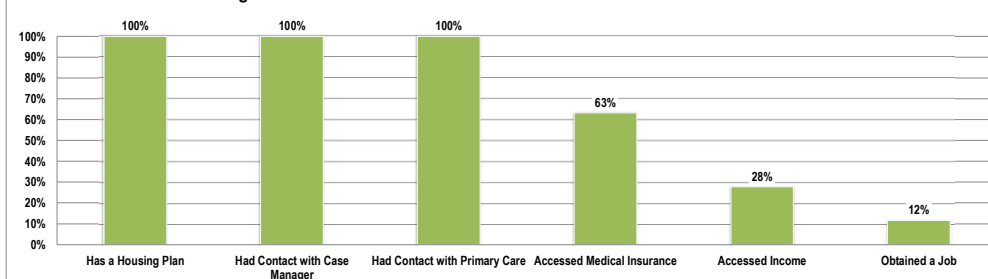
Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=144) is 92% Stable, 5% Temporary, 3% Unstable. Transitional/Short Term Housing Facilities (n=47) is 79% Stable, 12% Temporary, 9% Unstable. This Grantee did not provide: Permanent Housing, STRMU. Outcomes do not include households where head of household died during operating year.

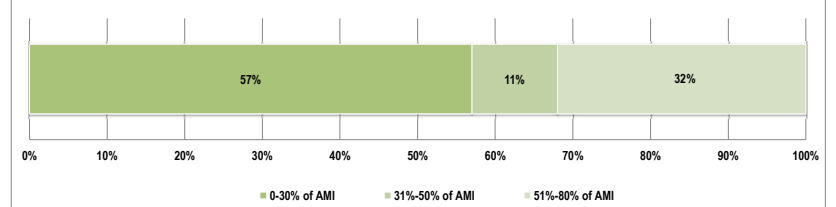

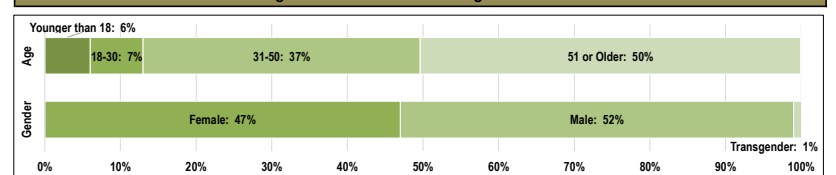

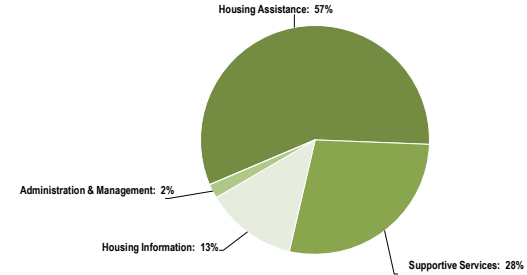

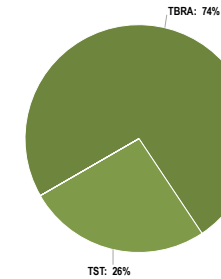

Percentage of Expenditures by Type of Activity



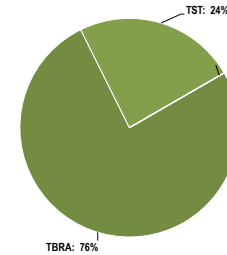
