


Outcomes by Type of Housing Assistance



Outcomes by Type of Housing Assistance: TBRA (n=476) is 97% Stable, 1% Temporary, 2% Unstable. Permanent Housing Facilities (n=3) is 100% Stable. Transitional/Short Term Housing Facilities (n=102) is 62% Stable, 8% Temporary, 30% Unstable. STRMU (n=139) is 98% Stable, 2% Temporary. Outcomes do not include households where head of household died during operating year.









Percentage of Expenditures by Type of Activity




