




Outcomes



Outcomes by type of Housing Assistance: Tenant Based Rental Assistance (n=1,983) is 95% Stable, 1% Temporary, and 4% Unstable; Permanent Housing Facilities (n=603) is 91% Stable, 3% Temporary, and 6% Unstable; Transitional/Short-Term Housing Facilities (n=258) is 82% Stable, 9% Temporary, and 9% Unstable; STRMU (n=861) is 42% Stable, 54% Temporary, and 4% Unstable. Outcomes do not include households where head of household died during operating year.

Access to Care and Support








Ethnicity Percentage of HOPWA Eligible Individuals Identified as Hispanic/Latino 14%




