

\$24,489 in funding is allocated under this activity to provide mandatory housing counseling services to those individuals receiving assistance through the Low-Income Down Payment Assistance Program and the Moderate/Middle Income Down Payment Assistance Program. The Housing Counseling Assistance Program identified in Waterford¿s NSP is not a separate program to assist 100 low/moderate/middle-income households, but rather the housing counseling assistance required to be provided to the 20 low-income households to be assisted through the Low-Income Down Payment Assistance Program and to the 80 moderate/middle-income households to be assisted through the Moderate/Middle-Income Down Payment Assistance Program. This direct association between the down payment assistance programs and the housing counseling assistance will be documented by the Township to ensure conformance with HUD regulations.

Action Plan Comments:

- Reviewer Changes in the Waterford Township NSP1 Action Plan consisted of moving funds from one activity to another. No new activities were developed. Funds were transferred to better assist homebuyers. Changes per activity are noted in the "Total Budget, Program Funds" & "Total Funds Amount" fields; these changes are not reflected in the "Activity Description" narrative. Waterford Township has one of the strongest NSP1 programs in the State of Michigan; very professional and results oriented senior staff leadership. kk
- Reviewer Minor movement of funds to be able to meet obligation deadline. Changes are reasonable and justified.
- Reviewer Per the Action Item sent 1/28/11 to NSP listserv recipients, the Grantee updated the DRGR Action Plan for each Housing activity performance measures. No dollar amounts were moved or changed.
