Areas of Greatest Need:

The Neighborhood Stabilization Program (NSP) provides emergency assistance to state and local governments to acquire and redevelop foreclosed properties that might otherwise become sources of abandonment and blight within their communities. The Neighborhood Stabilization Program provides grants to every state and certain local communities to purchase foreclosed or abandoned homes and to rehabilitate, resell, or redevelop these homes in order to stabilize neighborhoods and stem the decline in value of neighboring homes.

Distribution and and Uses of Funds:

The State of Iowa plans to allocate NSP resources to communities with the greatest need, and that have the interest and administrative capacity to operate the program. The State has determined that the most appropriate way to address these goals is to provide funding directly to Entitlement Communities, and have a competitive application process for the Non-Entitlement Communities. To determine an appropriate division of funding between the entitlement communities and the non-entitlement communities, the State proposes using a three-part formula. The three factors would include # of foreclosures, # of distressed/high-risk neighborhoods, and number of sub-prime loans. For the entitlements, the average of the three measures would be 38% (# of foreclosures) + 71% (distressed/high risk neighborhoods) + 45% (# of subprime loans). (38% + 71% + 45%) / 3 equals 51%. Using this figure of 51% to the Entitlement Communities, and 49% to the Non-Entitlements would result in the following: State Administration Up to \$864,287 (4% of the total award) Entitlement Communities \$10,579,231 Non-Entitlement Communities \$10,163,679 Total Funding \$21,607,197 A. Entitlement Allocation The allocation among the Entitlement Communities only has been calculated using the following formula: Number of Estimated Foreclosures in the community (weighted 60%), percent of sub-prime loans in the community (weighted 20%), and Foreclosure Risk (20%). After allocating the funds according to this formula and eliminating any allocations of less than \$250,000, the following totals are derived: Des Moines \$3,935,474 Davenport \$1,547,741 Cedar Rapids \$1,193,337 Council Bluffs \$1,184,874 Sioux City \$1,158,426 Waterloo \$850,570 Dubuque \$444,328 West Des Moines \$264,481 TOTAL \$10,579,231 If any of the eight Entitlement Cities above decide not to accept the funding, that amount will be allocated instead to the Non-Entitlement portion of the funding available to them by competitive application. B. Non-Entitlement Allocation As noted earlier, \$10,164,359 will be allocated for usage by non-entitlement communities, through competitive application. In an attempt to target these funds to communities with the greatest need, the following factors were employed to determine eligibility. Again using data provided by HUD, Block Groups were selected that met two criteria: they had a Foreclosure Risk Score of 9 or 10, and the Block Group in its entirety met the LMMI criteria. (They are Low, Medium or Moderate Income eligible if more than 50 percent of the households in the Block Group are below 120 percent Area Median Income - the NSP eligibility level.) Using these two criteria resulted in a list that includes 361 Block Groups in 98 different communities. These 98 communities (approximately 10 percent of all communities in the state) will be considered eligible to submit a Plan and apply for NSP funding.

Overall Progress Narrative:

The State of Iowa has implemented the follow measures for monitoring and program success:

1. Monthly unit detail reports are now due in addition to the Quarterly Report. Each month the sub recipients report their obligations, in dollars, per address and activity code. This will be used as a monitoring and technical assistance tool.



- 2. Establish benchmark goals for obligation for the sub recipients. 50% of award is to be obligated by March 30, 2010. In addition, there is a 75% obligation goal by June 1, 2010. Any sub recipient not obligating funds in line with the benchmarks is subject to reallocation of their award to a recipient that shows the capacity to obligate.
- 3. Monthly teleconference calls to share implementation strategies and technical assistance. All sub recipients are invited and provided with an agenda and related materials.
- 4. By April 1, 2010, it is the State of lowa's goal to complete a second round of onsite visits to the sub recipients. The visits were prioritized by percentage of funds needed to obligate. This has provided the sub recipients one-on-one opportunities to request assistance and have been productive work sessions.

The State of Iowa has also experience success, including the City of Des Moines. By the end of January they have obligated 54% of their 3.9M award. One of their major projects is the Southern Meadow complex. It is multifamily unit that will see the demolition of blighted wings and the rehabilitation of historically significant core building. It is anticipated that it will be converted into 30 affordable living units. In addition, the lot will accommodate new development of new affordable residential townhome units.

Activity 1 - Habitat for Humanity: On December 21, 2009, the City of Sioux City entered into a written agreement with Siouxland Habitat for Humanity in the amount of \$452,000, thus 100% of the funds for this activity are obligated. Siouxland Habitat for Humanity is now prepared to proceed with activities under Eligible Use B. They are currently in the process of identifying at least four foreclosed properties in the eligible census tracts that will be likely candidates for rehabilitation/resale to buyers at or below 50% of the area median income.

Activity 2 - Center For Siouxland: Center For Siouxland will be conducting housing counseling of the families purchasing a home under Activity 1. Once Habitat for Humanity has identified the homes that will be completed as part of Activity 1, an agreement will be completed with Center For Siouxland to conduct the Housing Counseling with families that will be purchasing the homes. It is anticipated that the agreement will be in place before March 31, 2010, making the funds 100% obligated at that time.

Activity 3 - Prime-Fallesen Development: The City of Sioux City has been conducting regular meetings with Developer Prime Fallesen Development regarding creation of a permanent supportive housing project. It has been determined that Activity 3 will fall under Eligible Use E. Prime-Fallesen has identified one project that could be



undertaken as part of this program. The City of Sioux City is also working with another developer regarding a potential neighborhood commercial use - likely a neighborhood grocery store. It is estimated that this activity has completed 20% of what is required to have the funds committed in the first 18 months of the grant.

Activity 4 - City of Sioux City: The City of Sioux City Inspection Services Division intends to demolish blighted properties in eligible census tracts. Many of the properties have already been identified as likely candidates for demolition. A contract is in place for demolition of 1201 Council Oak Drive, which will remain as green space in an existing City park throughout the affordability period. Demolition will begin as soon as the weather clears. 19% of the total funds set aside for demolition are now obligated.

Activities are well underway and include the following:

1)The City assisted Habitat for Humanity of Council Bluffs (Habitat) with the acquisition of five abandoned or foreclosed single family homes. Three of the homes will undergo housing rehabilitation and then be sold to households at or below 50% AMI. The addresses of these three homes are 3121 4th Ave, 308 Elder, and 2553 Ave C. After further inspection, the remaining two homes were found to be extremely blighted and not feasible for housing rehabilitation. These two homes will be demolished. Then a new home will be constructed on each lot and sold to households at or below 50% AMI. The addresses of these two homes are 1607 S 13th St and 1702 S 12th St. Also, the City and Habitat identified three more abandoned or foreclosed properties. The addresses of these three homes are 3105 Ave D, 2312 Ave D, and 1617 S 10th St. Appraisals, negotiations, and environmental reviews are underway on these properties.

2) The City met with Crossroads of Western Iowa to discuss the acquisition and rehabilitation of two abandoned or foreclosed residential properties for persons with developmental disabilities. The addresses of these residential properties are 2203 S 11th St and 2814 Ave K. Appraisals, negotiations, and environmental reviews are underway



on these properties.

- 3) The City acquired the vacant and blighted JB Towing properties. The properties consist of five parcels and are located at S 13th St and 4th Ave. The properties will be demolished, cleaned up and graded for public open space and/or a community garden. The properties are adjacent to the City's trail system.
- 4) The City identified two blighted properties for demolition. Both properties have been vacant for many years and pose huge health and safety concerns. One property is a large old motel located at 2325 Ave N. The City has obtained ownership of the property through a petition filed in the Iowa District Court for Pottawattamie County pursuant to Iowa Code 657A allowing for Cities to take title to abandoned and unsafe properties. Demolition bids are due February 28, 2010. The other property is an old day care and warehouse located at 1028 Creek Top. A purchase agreement has been executed and closing is scheduled for March 31, 2010 and demolition is scheduled for June 30, 2010.

As of January 31, 2010 approximately 40% of the NSP funds have been expended or obligated. Project is 20% complete.

This quarter the City has been continuing work to implement the NSP. To date, the City has allocated \$2.2 million of NSP funds, which is 57% of our total allocation. These funds have been allocated in five basic areas: redevelopment of the Southern Meadows Apartments, restricted income program with Habitat for Humanity, our middle income single family home program, neighborhood commercial redevelopment, and program administration. The last tenants of the Southern Meadows Apartments moved out in mid-December, and the City is looking to close on the property in late January or early February. We are still waiting for final approval from IDED to move forward with this acquisition. Habitat for Humanity has either closed or entered into purchase agreements for 11 properties to assist families at less than 50% AMI. We plan to launch our revised middle income single family home program in late January. We believe this \$1.2 million will be allocated by the middle of March 2010. The Neighborhood Development Corporation will be closing on several vacant properties they will acquire to enhance a commercial development in mid-January.
