Overall Progress Narrative:

The City, through its NSP partners, has acquired 15 houses; expended \$1.67 million of NSP funds, and obligated another 490,000 for 15 homes during the reporting period ending 12/31/2009. NSP Partners have been setting up their own internal processes in anticipation of receiving the funds and through their vast experience program outlays are occurring at a very fast pace. The NSP outlays were \$1.21 million for a four week period of time that included the holiday season. This expenditure rate exceeds the NSP national average of 10%.

The City continues to work diligently to expend the NSP funds and expects January NSP expenditures to exceed \$2 million and anticipated escrows for February to exceed \$2 million, with 50% directed acquiring and rehabilitating a property that meets set-aside requirement.
