The City of Hamilton Neighborhood Development Division (NDD) staff continues to develop projects and criteria to be used for demolition, acquisition, rehabilitation/reconstruction and new construction activities to stabilize neighborhoods. Staff has aggressively been working with lenders, realtors, appraisers, legal council, OHPO, and environmental consultants in efforts to get activities underway. Progress in the month of July:

- Inspections of ten (10) blighted properties declared as nuisances by the City's Health Department; taken before City Council for approval for demolition; civil cases filed in the Common Pleas Court by the City's Law Department.
- Letters mailed to OHPO for historic review and determination of No Adverse Affect for nine (9) properties proposed for demolition.
- Property inspections of five (5) Lender Owned foreclosed properties; received responses of interest from lending institutions.
  - Sixteen (16) properties identified for potential acquisition.
  - Seven (7) exterior inspections completed for possible rehab/reconstuction or demolition.

Progress in the month of August:

- Request for Proposals (RFP) for URA Appraisals analyzed and mailed to five (5) appraisers.
- Meeting with Neighborhood Housing Services of Hamilton (NHSH) to discuss property acquistion, disposition and management options for potential contract agreements.
- Five (5) properties inspected for possible rehabilitation; staff recommended two (2) properties located at 130 Gordon Avenue and 614 S. 4th Street.
