Activity Progress Narrative:

Corporation for Affordable Homes of McHenry County has completed the procurement process and has hired the Project Manager and Construction Manager for the overseeing of the NSP activities under contract with McHenry County. The project manager has been working with the banks to negotiate bulk sales purchase and first look. Bank of America held a webcast meeting with staff to set up an account. Realtors awarded regions within the County have been working through site lists with the Project Manager to locate potential sites. The Construction Manager has been brought up to date with the expectations for the NSP program and has several site inspections to attend with McHenry County in the beginning of the 3rd

Quarter. Corporation for Affordable Homes is continuing to hold Orientation Sessions and attend program trainings with lenders and network with other NSP recipients for strategy plans and outreach in order to promote the program and get the most impact for the County communities.

NSP eligible activity (B) Purchase and rehabilitate homes and residential properties that have been abandoned or foreclosed upon, in order to sell, rent, or redevelop such homes and properties. Correlated CDBG eligible activity 24 CFR 570.201. This activity will meet the NSP requirement to provide counseling services may include, but are not limited to eight hours of counseling (required), individual financial literacy assistance, individual case management and follow-up. Counseling services will include initial consultation, and fast track 8 hours counseling for eligible participants whose credit is in good shape. Participants whose credit needs some repair will work with the Subrecipient's guidance to repair credit and be educated on budgeting for homeownership over a greater than 8 hours minimum counseling time.

Activity Progress Narrative:

Counselors met with 13 clients this quarter to determine their readiness to purchase a home. The clients come to Consumer Credit Counseling Services after attending an NSP Orientation conducted by Corporation for Affordable Homes. After the orientation, the client obtains a voucher signifying that they have attended the orientation. The client voucher also functions as a way to track clients at the initial counseling from other grant funded counseling programs that are available. Of the clients counseled, 5 were deemed Fast Track (ready to purchase), 3 were deemed Homebuyer Club (need some time) and 5 were deemed Self Directed (need to work on their credit). The Fast Track classes, 3 clients attended and completed classes and are ready to purchase a home. Of the two other clients, 1 dropped out and 1 will be attending a future class. Homebuyer classes start in the next quarter.
