Overall Progress Narrative:

Demolition activity continues operating smoothly. The amendment referred to in the previous QPR to expand the target area and depth of homeowner assistance was presented for public comment and submitted to City Council for approval. In addition to the previously mentioned changes the amendment included a proposal to allocate funding in the approximate amount of \$1.16 million to a new activity construction of a neighborhood resource center. The funding for this activity was to come from a \$0.5 million reduction in the demolition line item and a decrease of approx. \$0.66 million in the allocation for the acquisition rehabilitation activity NSP-03. This amendment was very controversial because it called for the closing of an existing library and recreation center. The Warren City Council voted on the amendment on December 15, 2009 and it was not approved.

In the next quarter, the homeownership assistance activity will be launched as originally proposed; the contract with Macomb Habitat for Humanity for new construction will be executed; and the City will request proposals from developers to manage the acquisition rehabilitation activity.
