Evanston received approval of its revised NSP2 budget (Appendix A) based on its award of \$18.15 million. Activities in the first quarter of 2010 include completion of the Tier 1 environmental review and public comment period. The City's request for release of funds was received by the Environmental Officer at the Chicago HUD office on 4/5/2010. Meetings have been held with the aldermen and residents of the wards that comprise the target geography to provide information on the program. City staff and Brinshore Development LLC are identifying potential eligible properties in the target geography and contacting banks about REO properties under consideration for acquisition when funds are released.
