

State of North Dakota Commitments Trend (Monthly Commitments)










State of North Dakota Commitments Versus Total Grant Amount



State of North Dakota Expenditures Trend (Monthly Expenditures)




State of North Dakota expended \$16,934 during April and needs to average \$419,514 per month for May 2010 through February 2013
