






Wyoming State Program Commitments Trend (Cumulative Commitments)




Wyoming State Program Commitments Versus Total Grant Amount



Wyoming State Program Expenditures Trend (Monthly Expenditures)




Wyoming State Program expended \$614,141 during March and needs to average \$478,065 per month for April 2010 through February 2013




