

Lansing, MI committed \$712,000 during March and needs to average \$413,589 per month for April through August




Lansing, MI Commitments Trend (Monthly Commitments)



Lansing, MI expended \$196,015 during March and needs to average \$146,754 per month for April 2010 through February 2013




