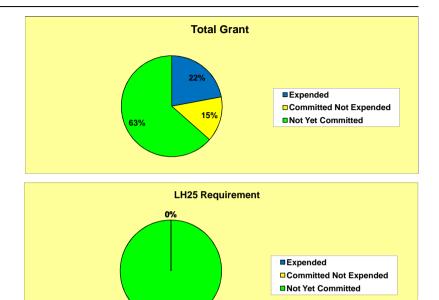

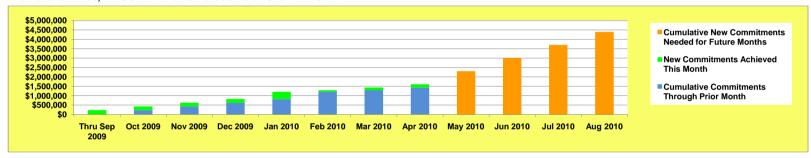

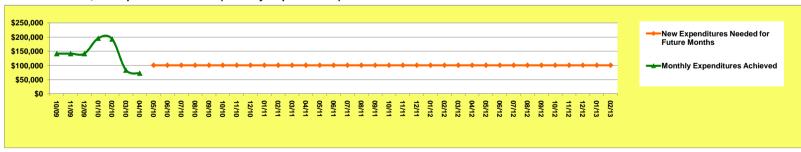
Pembroke Pines, FL Commitments Trend (Cumulative Commitments)

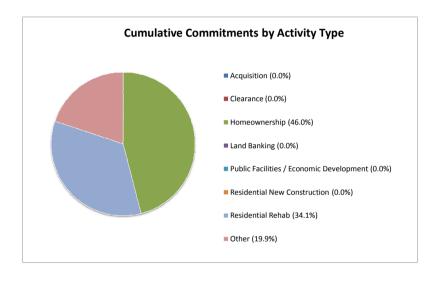

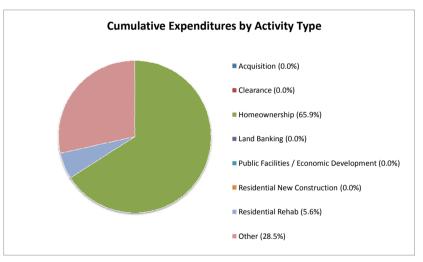
