PUBLIC FACILITIES AND IMPROVEMENTS



Eligible Public Facilities Activities

- Infrastructure
 - Streets, sidewalks
 - Water, sewer facilities/lines
- Neighborhood facilities
 - Parks, playgrounds
 - Recreational facilities
- Facilities for special needs populations
 - Homeless shelters
 - Group homes





Eligible CDBG-CV Public Facilities Activities

- Construct a health facility for testing, diagnosis, or treatment.
- Rehabilitate a community facility to establish an infectious disease treatment clinic.
- Acquire and rehabilitate, or construct, a group living facility that may be used to centralize patients undergoing treatment.
- Acquire a building and rehabilitate it to provide single occupancy housing units.
- Rehabilitate a facility such as a homeless shelter or senior center to allow social distancing in common areas (such as dining and recreation rooms).



Eligible CDBG-CV Public Facilities Activities (Cont.)

- Construct a public facility, such as a park, serving an LMI area, to provide suitable outdoor fitness, and social space where insufficient facilities are available to support social distancing guidance.
- Acquire, and rehabilitate (if necessary) a motel or hotel building to expand capacity for non-congregate shelter or enable permanent housing where such housing is not sufficient during a coronavirus pandemic or epidemic.
- Rehabilitate a community facility to establish appropriately ventilated spaces for senior or youth services and activities.

Eligible CDBG-CV Public Facilities Activities (Cont.)

- Construct a public improvement, such as extending broadband infrastructure in an underserved area or reconstructing degraded water lines, to support tele-school and telemedicine and to ensure potable water to homes, schools, and health providers.
- Rehabilitate a commercial building or public facility such as a school building to improve indoor air quality and ventilation to improve public health and prevent spread of coronavirus by replacing the HVAC and other building systems or to add operable windows and other improvements that could ensure the building's continued usefulness during an outbreak.

Special Assessments

- Special assessments are used to recover capital costs through a fee or charge
- Under CDBG, two ways to think about special assessments:
 - To recover costs of CDBG-assisted public improvements
 - To pay private assessments for low/mod owner occupants
- Low/Mod Area Benefit
 - May be limited to only Low-Income persons when grant funds are insufficient to pay for <u>all</u> Low/Mod-Income persons



Ineligible Public Facilities Activities

- Maintenance and repair of public facilities
 - Exception for handicapped accessibility
 - Operating and maintenance costs
 - Exception for costs related to carrying out a CDBG public service activity in a public facility
- Buildings for general conduct of government (e.g., city hall)
 - Some exceptions
