WIN prepares families to purchase their first home by offering homebuyer training classes and individual counseling. Our training also focuses on working with families to save homes from foreclosure.

WIN works to train and empower community leaders to work with their community, local & national resources, and local governments to resolve community issues and build thriving vibrant, stable communities.

### Challenges

- During the recession we lost a lot of agencies
- Diversifying our funding streams
  - HOME Community Housing Development Organization (CHDO) for City of Cincinnati
  - Owner of affordable rental housing through the Low-Income Housing Tax Credit (LIHTC) program



### **Creative Partnerships**

- How do we think about creative ways to do contract work with other organizations?
  - Landbank bought <u>194 single family homes</u> from out of town investor to turn into homeownership
  - WIN contracted with the Landbank to provide the current renters the opportunity to buy their homes
  - Increased staffing needs
  - Diversify your relations for the long-term benefit of growing your programs



### WIN's Financial Stability Program

- Client focused
  - Provides a foundation to prepare for home ownership, especially for people who are not ready to buy, but do have a goal to purchase within the next 12-24 months
- Organization focused
  - There is a need to focus on individual families as well as neighborhoods to ensure our work is helping to build the neighborhood stability and long-term racial wealth.

### Community Engagement

- Engage community to support agency goals. Speak your truth.
- People fear change, but there is nothing constant but change – package and deliver it in non-threatening ways
- "Moving Forward Transition Plan" informs stakeholders in real time and opens the door to partnerships/support
- Who are the stakeholders who benefit from and need our services – Be inclusive through continuous transparency.



### Agency Sustainability

- Assess performance
- Set goals for improvement
- Establish timelines
- Determine composition of the team
- Identify deliverables
- Develop evaluation method(s)
- Report Sell your successes; be honest about your fails; don't be afraid to reset



#### Moving Forward

- A critical part of change is creating a path forward What guides your agency?
- Hard decisions –current condition and future vision
- Who do we serve? How are we doing? What can we change?
- Our plan focuses on key changes being implemented to improve the operations and condition of the agency which in turn improves the services it provides to its clients (e.g., management changes, sale of properties, re-organizing the agency, obtaining revenue to sustain the agency, etc.).



### Change Management

- Succession planning within organizations like housing counseling agencies and other affordable housing agencies is critical in a time of less Federal investment and more need.
  - Determine who will shape it?
  - What critical factors should be included
  - How will it become part of the strategic goals for your counseling agency?
  - Who are the potential successors?
- Create a plan that out lives the present and takes your agency into an upward (and stable) trajectory into the future






