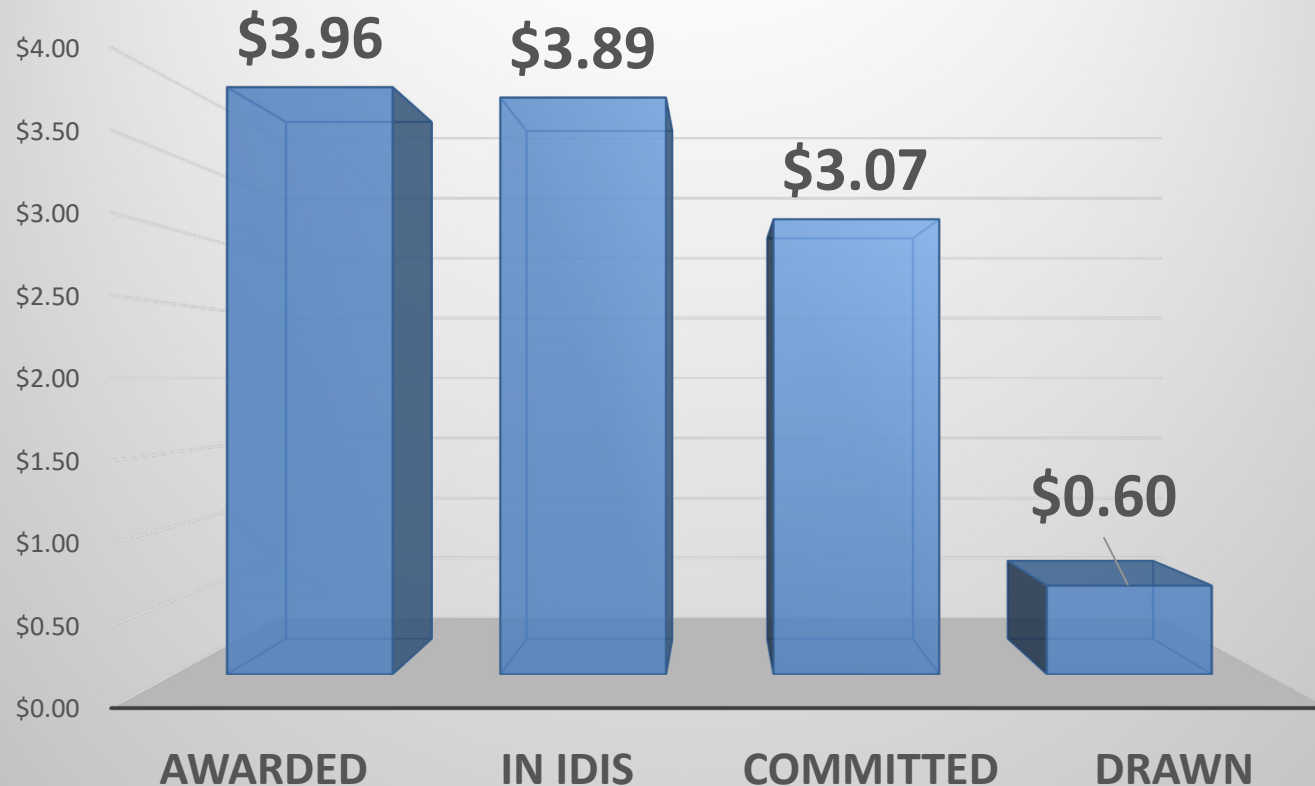


ESG-CV Expenditure Progress

ESG-CV Funds (in billions)



- **98%** of funds obligated in IDIS
- **78%** of funds committed
- **15%** of awarded funds drawn
- **Reminder:** 20% of ESG-CV grant allocations must be expended by September 30, 2021

Uses of ESG-CV Funds

- **Providing infectious disease training and mitigation resources** such as Personal Protective Equipment, access to handwashing stations, etc. to provider staff and program participants
- **Adapting and expanding emergency shelter options**, including non-congregate shelter options such as hotels and motels
- **Rapidly re-housing** individuals and families at scale
- Providing **homelessness prevention** assistance
- **Supporting COVID-19 testing and vaccination** efforts

New ESG-CV Notice

- [Notice CPD-21-08](#) issued July 19, 2021
- Supersedes Notice CPD-20-08
- Reestablishes the allocation formula and amounts, and reestablishes and announces new requirements for ESG-CV funds
- Note: [Notice CPD-21-05](#) continues to apply without alteration

New ESG-CV Notice: Highlight of Key Changes

- **Removes the January 31, 2022 limitation** on costs of providing emergency shelter or temporary emergency shelter
- **Allows conversion of temporary emergency shelter** acquired or improved with ESG-CV funds into emergency shelter without triggering disposition
- **Aligns eligibility and re-evaluation income limits** for prevention and rapid re-housing
- **Provides new rental assistance allowances**, including flexibilities for project-based rental assistance and allowance of subleases
- **Removes time limitation on services or rental assistance** while receiving ESG-CV assistance
- **Allows for subawarding funds to Indian tribes** and tribally-designated housing authorities

HOPWA CARES Act Overview



- CARES Act provided \$65M in supplemental funding for HOPWA
 - \$53.7M for formula grantees using the same data elements to determine their FY2020 HOPWA formula allocations
 - \$10M in one-time, non-renewable funding for competitive grantees that is proportionate to their existing grants
 - \$1.3M to Technical Assistance providers as an increase to prior award

HOPWA CARES Act Update

HOPWA-CV Funds



As of July 15, 2021

- 97.6% of HOPWA CARES Act grants have been contracted
- 83% of CARES Act grantees have made their 1st drawdown
- 33% (\$17,846,139.98) of CARES Act Formula funds have been disbursed
- 33% (\$3,217,445.11) of CARES Act Competitive funds have been disbursed
- 8 grantees have spent 100% of their CARES Act funds

HOPWA CARES Act Update

How are HOPWA CARES Act Funds being used?

- Mitigate the increased risk of housing instability
- Prevent evictions
- Prevent homelessness
- Ensure adequate space for isolating or quarantining
- Address difficulty in accessing food, medications, medical care, and vaccines
