Overview

The following is a summary of changes that occurred in DRGR Release 7.15:

Module	Affected Users	Summary
Grant Management Action Plan	Grantee users	The sum of Grant Award + Estimated PI was not totaling on the Edit Action Plan screen. This defect was corrected.
Grant Management Action Plan	All users	Grantees will be blocked from creating drawdowns for newly created activities until the Action Plan is reviewed and approved (see separate Fact Sheet).
Grant Management Action Plan	All users	The ability to delete and restore deleted activities, including those with prior drawdowns, was enhanced (see separate Fact Sheet).
Grant Management Action Plan	Grantee users	A defect that allowed the sum of project budgets to exceed the Grant Award + Estimated Program Income was corrected.
Grant Management Performance Report	Grantee users	The QPR screens were enhanced to allow grantees to enter data required on the SF-425 report not already captured in DRGR (see separate Fact Sheet).
Financial	Grantee users	A defect was corrected that prevented users from creating a voucher using Program Funds and Program Income for two or more activities on the same voucher.
Compliance	All users	Although a concern was closed, the View Concern screen would show the concern was open. This defect was corrected.
Compliance	All users	The performance of adding/editing oversight events and sub-events was improved.
Compliance	HUD users	Changes were made to Finding and Concern screens to more closely align with HUD's standard Finding and Concern format. The ability to add Regulatory Citations was also added.

Module	Affected Users	Summary
Grant Management Grant Close-out	All users	Changes to the grant close-out process and closeout status were made (see separate Fact Sheet).
Administration User Requests	HUD users	A defect preventing HUD users for initiating New User, User Modification and Deactivation requests was corrected.
Administration Login	Users with Multiple Profiles	A defect that caused a system error at login was corrected.
Utilities - Reports	All users	Permanent corrections were made to the P.L.113-2 dashboard.
Emails	All users	The following defects related to emails were corrected: SSA(s) were receiving voucher approval emails when they should not; emails were not being sent when new user requests were created and approved by same HUD user; voucher approval emails were not distinguishing between approved and rejected vouchers; and multiple emails were being sent for voucher revisions.
Systemwide	All users	The design and navigation of DRGR was updated (see separate Fact Sheet).
Systemwide	All users	Several defects were corrected that caused users to activate Compatibility View. Users should no longer need to activate Compatibility View.
Grant Management Action Plan	TA Provider users	Removed ability for TA Provider users to edit Project Budgets; ability reserved for HUD TA Users.
Grant Management Work Plan	TA Provider users	Added ability to delete and restore deleted work plans not associated with prior drawdowns (see separate Fact Sheet).
Grant Management Work Plan	TA Provider users	A defect that allowed the sum of work plans to exceed the associated project budget was corrected.
Grant Management Work Plan	HUD TA users	Enhanced ability to re-open closed work plans and update approved budget via upload function.
Financial	TA Provider users	Added ability to access work plans from voucher search page.
Administration TA Staff Rates	HUD TA users	Added ability to activate inactive staff rates.
