Overview

The following are highlights of enhancements and new features that are available in DRGR Release 8.1:

Functionality	Affected Users	Summary
Login	All Users	A single login page is available for all users of CPD grant management systems to navigate between the systems quickly. The login page is accessed at https://cpd.hud.gov/gmportal/ .
Main Navigation Menu	All Users	The design of the main navigation menus is updated to include a heading. Also, links that do not require the specification of a grant in the locked grant field are now indicated by a blue globe () icon.
Home Page	All Users	The summary panel is removed. Instead, the total number of action items are shown next to each action item section heading. Users can expand and collapse the entire list of action items by selecting heading.
Searches	All Users	New functionality is added to search sections of the Action Plan, Projects, Activities, Grantee Program, Performance Reports, and Grants pages. Users can now collapse the search form to see more results without scrolling by selecting the arrowhead icon next to the “Search Criteria” heading. The search results are also exported as CSV, PDF, and Microsoft Excel files.
Action Plan	All Users	The design and navigation of the Action Plan screens is updated. The Action Plan screens are now using a tabbed interface with modals for editing the content. See the Action Plan section of the DRGR User Manual for complete details.
Reports	All Users	The download templates for data uploads and the Audit History Reports are migrated from the legacy DRGR OLAP project into the new DRGR Data Analytics project, in addition to the remaining OLAP reports as noted in the table below.

Functionality	Affected Users	Summary
Monitoring	HUD Users	GMP-M and GMP-R are integrated into the DRGR system as separate modules.
System for award management (SAM) interface	All Users	SAM interface was not functioning correctly in R8.0. Users can now associate grantees and responsible organizations to SAM registrations.
User Requests	All Users	A user without the <i>Request User Profile</i> role can no longer submit user requests in DRGR.
TA Work Plan	Grantee Users (TA Providers)	The maximum character limit on the Scope field of the TA Work Plan is increased to 4000 characters.
QPR/ SF 425	All Users	Defect related to obligation amounts on the SF-425 is resolved. A data correction is no longer needed to display the correct amount.
