### Overview

The following is a summary of changes that occurred in DRGR Release 8.3:

Module	Affected Users	Summary
<b>Home Page</b>	HUD Users	For grants set up with the Public Action Plan (PAP) feature, HUD Public Action Plan reviewers will receive PAP Pending Action Item(s) on the system's Home Page when PAP's are submitted for review.
<b>Action Plan History</b>	All Users	The system now provides users with the ability to compare versions of historical Action Plans via the History tab.
<b>Action Plan Review</b>	HUD Users	HUD Users are now able to review Public Action Plans, if grants are set up with the Public Action Plan feature.
<b>Action Plans</b>	Grantee Admins	Grantees with Submit Action Plan privileges are now able to submit Public Action Plans for review if grants are set up with Public Action Plan feature.
<b>Search Action Plans</b>	All Users	The Search Action Plans screen now allows users to search for Public Action Plans for grants that are setup to use the PAP feature.
<b>Grantee Programs</b>	Grantee Users	When editing Estimated Program Income (PI), a rule was added that the sum of grantee program budgets cannot exceed the sum of the grant award amount and estimated PI.
<b>Reports</b>	TA Providers	TA Provider reports show work plan history by date (amendment by HUD approval date, changes not requiring HUD approval by TA Provider submit date).
<b>Performance Report</b>	All Users	For Performance Reports, a defect was corrected and the system now links the Performance Report to the correct approved action plan (for grants that use Public Action Plans)
<b>Manage Action Plan</b>	All Users	On the Manage Action Plan - Activities Tab: The user interface now displays a "Status" field for the search criteria and a "Status" column in the search results table.
<b>Action Plans</b>	Grantee Users	For Action Plans, the system validation of action plan performance measure totals (Beneficiary Measures, Housing Units and # of Households) was corrected.
<b>Action Plans</b>	All Users	On the View Action Plan screen, the history tables sort order has been updated to show from most recent to oldest.
<b>Action Plans</b>	HUD Users	For Action Plans, dates entered in Block Project/Activities are now displayed correctly. Previously, there were cases where the date was displayed one day behind in previous versions of DRGR.

Module	Affected Users	Summary
<b>Action Plans, Projects</b>	HUD Users, TA Providers	A rule has been added to the system that prevents the Action Plan status for TA awards from being changed to "Modified - Resubmit when ready" when projects are modified.
<b>Manage Activity and Reports</b>	HUD Users	The DRGR user interface and MicroStrategy (MSTR) Reports are now displaying the correct Activity Block Status (Drawdown Block Attribute for Consolidated Grant Child Activities).
<b>Activity</b>	All Users	For Consolidated Grants, a system defect was corrected to now update the activity number on child activities correctly when the activity number is updated in the parent grant.
<b>Activity, Performance Report</b>	Grantee Users	Grantee users are now able to save narratives in the Narrative tab of the Manage Performance Report Activity page.
<b>Drawdown</b>	Drawdown Approvers	A defect was corrected to allow Drawdown Approvers to approve revisions when selecting the option in the 'Action' column.
<b>Drawdown</b>	All Users	On the Program Income search page, users can now navigate to all search result pages.
<b>Manage Activity</b>	Grantee Users	For Census activity(ies), the system is no longer replacing Low and Mod projections values with "12" after updating the Geography Tab.
<b>Reports</b>	All Users	MicroStrategy Report A21 in DRGR Analytics was corrected to no longer show duplicate records.
<b>My Profile</b>	All Users	A defect was corrected to allow the system to display the Rules of Behavior screen after users are recertified.
<b>Performance Report</b>	Grantee Users	For Performance Report submissions, the system is validating SF-425 metric data.
<b>Performance Report</b>	All Users	If the grant is not setup to use the Public Action Plan feature, the system was corrected to no longer display Proposed values on the Measures tab of the Performance Report.
<b>Performance Report</b>	Grantee Users	On the Manage Performance Report Activity Page - Measure Tab, Grantee users are now able to enter the applicable Race data breakdown when Beneficiary reporting type is set to Direct Benefit - Persons.
<b>Performance Report</b>	Grantee Users	Grantee users with the Submit Performance Reports role are now able to submit Performance Reports for approval when there is a carriage return in the text entered on the submission comment field.
<b>Performance Report</b>	All Users	Performance Report PDFs are now displaying Survey or Census in the Benefit Type field, as applicable.
<b>Projects, TA</b>	Super Users	Super Users are now able to edit projects for TA Award grants in the system.
<b>Reports</b>	All Users	Narratives within MicroStrategy Analytics Report A32 has been fixed.
<b>Drawdown</b>	Drawdown Requesters	System configuration has been updated to not allow users to create vouchers for activities with a status of "planned" or "completed".
