Administration	Super Users	A new "Manage Public Site" function has been added to the system to allow Super Users the ability to manage folders and files on the DRGR Public Data Portal site.
Flags	Grantee Users	DRGR flags function under the Compliance Module has been added to support grantee's "Acknowledgement" of flags. Presently only configured for TA grantees.
