#### **HPRP Reporting Systems**

#### IDIS

- Financial information (tracking expenditures)
- No Beneficiary Data (differs from CDBG, HOME)
- HMIS
  - Collects unduplicated HPRP client-level data
  - Generates HPRP QPR and APR

e-snaps

- Collects HMIS-generated HPRP QPR and APR
- Federalreporting.gov
  - Collects basic performance information for ARRA programs (including HPRP)

#### **IDIS: Role for HPRP**

Disburse Funds Collect Expenditure Data activity type - organization Monitor Grant Generate financial reports grant and program level – organization and activity level – financial transaction level

# IDIS: Factors That Influence Report Accuracy

- Grantee Policies and Procedures, IDIS Data Entry and Accurate Financial Information
- Project and Activity Structure
- Naming Convention
- One-Day Report Lag
- If you are not meeting these standards, it is not too late to start.

#### IDIS: Important Considerations For Policies and Procedures

Establish Procedures
 Setting up programs and activities
 Funding programs and activities
 Monitoring IDIS for quality data

Timely data entry and invoice processing are critical.

#### IDIS: Important Considerations For Policies and Procedures

#### Project Disbursements

- Grantees must draw funds at least quarterly in IDIS
- HUD recommends drawing funds more frequently

 Reimbursement vs. Cash Advances

 Grantee choice and responsibility to understand regulations and track

#### IDIS: Project and Activity Structure

Proper IDIS data entry is outlined in <u>www.hudhre.info</u> document "Using IDIS for HPRP Financial Management"

Projects MUST only be set up under the 2009 program year

Project must represent HPRP Subgrantee or Organization

# **IDIS:** Project and Activity Structure

Each Project must be associated with at least one activity in IDIS:

- Homeless Prevention
- Homeless Assistance (Rapid Re-Housing)
- Data Collection and Evaluation
- Administration
- Each activity must be set up separately
- Proper set up leads to more useful and meaningful reports

#### IDIS: Project Naming Convention

HPRP Projects follow this standard:

 First: "HPRP"
 Second: Organization name
 Example: "HPRP-Helping Hands"

 Following the suggested naming convention allows for more useful and meaningful reports

# IDIS: Activity Naming Convention

#### HPRP Activities follow this standard:

- First: "HPRP"
- Second: Activity Abbreviation
  - HP-Homeless Prevention
  - HA-Homeless Assistance
  - AD-Administration
  - DC-Data Collection and Evaluation

Example: "HPRP-HA"

Inconsistency can lead to mixed-up data and the risk of incorrect conclusions

#### IDIS: Activity Naming Convention

- Special case for "Data Collection and Evaluation" (DC)
- Initially DC was not available in IDIS and communities could set up DC activity under HA
- Grantees should correct this immediately by setting up a separate activity named: HPRP-DC

#### **IDIS: Reporting & One-Day Lag**

MicroStrategy Report Module

- Make sure browser settings allow pop-ups
- Return to IDIS while working in MicroStrategy or you will time out after 20 minutes
- One-day report lag
  - MicroStrategy contains data from the previous day
  - MicroStrategy is refreshed nightly

Grant Commitments, Drawdown Rates, & Drawdown Projections – PR61, PR60 Financial Status at Sub-grantee and Activity Level – PR02 Financial Transactions – PR05, PR07

# Review for Timely Expenditures Monthly Start at grant level and work down Act on information Monitor/assist slow spending sub-grantees Re-allocate funds within grant Reconciliation Recommended quarterly

#### **IDIS Report Group I**

HPRP-specific reports that help analyze grant commitments, drawdown rates, and drawdown projections

HPRP Expenditure Deadline Report Progress to Date State, grantee, HPRP grant amount Draws to date Grant Agreement Date 2- and 3-year Requirement Date, days remaining, and dollars remaining

#### Considerations:

- Look at days remaining for 60% and 100%
- Report establishes the Grant Agreement Date that sets the 60% and 100% deadlines
- Ensure that the "Draws to Date" match up with internal financial records
- "()" indicates your community has met the expenditure deadline

Analysis:
 Easy Calculation for Daily/Monthly Expenditure requirements

Days Remaining = 100 Expenditures Remaining to 60% = \$1,255,000

\$1,255,000 / 100= \$12,550 per day \$12,550 x 30= \$376,500 per month



#### Considerations:

- Funds Committed must equal 100%
- No more than 5% committed to Admin
- Data Collection and Evaluation tasks should not be included in Admin
- Compare actual committed amounts with contracts
- Compare actual drawn amounts with internal financial records


- Substantial Amendment to the Consolidated Plan
  - Follow Citizen Participation Plan for HPRP fund reallocation process
- Look at funded amounts for HA and HP vs. Expended amounts for HA and HP
  - Are you expending one faster?
  - Will reallocating funds allow you to meet expenditure requirements?

# IDIS Report: PR60 (Page 2)

- Assess quarterly acceleration/deceleration of draws
- O expenditures in Q1 or Q2 is common, other instances of 0 indicate issues
- This report only includes vouchers submitted to LOCCS

# IDIS Report: PR60 (Page 2)

### Considerations:

Large increases or decreases in the expenditures for the quarter indicate inconsistent invoicing or IDIS data entry

Current quarter amounts will continue to grow as IDIS is updated throughout the quarter

# PR07: Drawdown Report by Voucher Number

- Two versions: all vouchers or vouchers submitted to LOCCS
- Drawdown Report by Voucher Number
- Displays the details for all draw downs in date order
  - Voucher #, Status
  - Created, Status and LOCCS dates
  - Grant #, Recipient TIN
  - Amount of the Draw

# PR07: Drawdown Report by Voucher Number

- Reconcile individual payments between IDIS and internal financial records
- Verify that the correct payments were made to the correct activities/programs
- Review the various dates: voucher created date, voucher status date and LOCCS send date to make sure there are no critical time lapses
- If errors are found Grantees should Revise vouchers

## **Action Steps**

- Update IDIS with financial information in a timely manner
- Run IDIS reports on a regular basis
- Use the IDIS data along with client data to make HPRP program decisions
  - Accelerate or Decelerate expenditures
  - Re-allocate funds between activities or sub-grantees
