The GIS-based Housing Suitability Model (HSM) seeks to determine the suitability of locations for the purposes of siting or addressing gaps in affordable or workforce housing. The Affordable Parcel Inventory (API) seekks to estimate the affordability of all residential parcels in the region by estimating their combined housing and transportation-related costs.

SE Florida developed Regional Opportunity Network and SE Florida Data Common groups

Two collaborations are under continued development as part of this process. One, the Regional Opportunity Network, a coalition of community-based organizations, individuals, and other organizations that care about improved health, transportation, economic opportunity, and justice etc. for all communities. They recognize that there are existing barriers to opportunity and are interested in continuing to explore what we need to do to overcome them. Working with PolicyLink and other partners, South Florida Regional Planning Council came together to learn about best practices around the country. This group also held a workshop with a member of the Consultant team to provide comments and input into the Seven50 draft plan before its finalization.

The second network/collaboration that is under development is a broad-based group of organizations that work with myriad data – economic, health, transportation, housing, etc. In partnership with the Miami Dade Economic Advocacy Trust, Citi Community Development and CBI Boston MAPC and Place Matters, we are working to create a SE Florida Data Common that will create a shared collaborative space for data collection, visualization, and analysis. Technical assistance in the areas of data management and DataCommons continues to be very important as does assistance in the areas of community engagement, equity and regional opportunity networks.

MARC develops Sustainability Indicators to measure success and track progress

MARC collected a wealth of data on the St. Louis Region, including population, employment, income, transportation, air quality and education levels to help communities identify critical needs, initiate action and measure their progress over time. From this wealth of information, MARC identified a set of indicators to measure progress, developing a process to periodically evaluate those indicators, and adjusting policies and programs based on the evaluation. MARC created a new indicators website that serves three purposes: It provides an up-to-date source of data to help individuals, organizations and institutions better understand their community. It The Creating Sustainable Places Indicators are structured to provide a clear link between quantitative measures and policy decisions. To do this, indicators are categorized on three levels: Actions, Places and Outcomes:

Actions: Measures actions promoted by Creating Sustainable Places. These are tangible actions that could be anything from construction of new affordable housing units to adoption of Complete Streets ordinances.

Places: Measures the impact of the actions on specific places or corridors. These are the characteristics and improvements our places need if they are to become more sustainable.

Outcomes: High-level indicators that measure whether we are meeting triple-bottom-line priorities. Are we taking actions that create places that are thriving — economically, environmentally, and socially?

NY Governor Cuomo Announces \$70 Million in Funding for 68 Bicycle and Pedestrian Projects; \$480,000 to Glens Falls School Bicycle and Pedestrian Improvements

10/27/2014

The City of Glens Falls has been allocated \$480,000 for the Fire Road, Crandall Park and Kensington Road Elementary School Bicycle and Pedestrian Improvements.

Ed Bartholomew stated that today's announcement represents an important collaboration by the City of Glens Falls with Glens Falls School District, YMCA and the Adirondack Glens Falls Transportation Council which has resulted in a substantial and important safety project going forward..

This project recommended by the recently concluded "City's Community Challenge HUD Grant" will greatly enhance safety for bicyclists, pedestrians who walk, and ride in the Kensington School, Crandall Park YMCA / Fire Road area.

The improvements include new sidewalks, multi- use path and raised crosswalk along Kensington Road, Jerome Avenue and Fire Road in the City of Glens Falls, thus formally connecting several major and important pedestrian generators including an elementary school (K-4), YMCA and significant public park facilities with separate accommodations for pedestrians and bicyclist of all ages;

The estimated Project cost is \$\$575,000 to \$600,000 with 80% coing from state funding and 20% from local matching funds.

The goal of promoting social equity is implicit in RPA's objectives, and is to be incorporated in strategies and initiatives under development across eight program areas—housing, economic development, transportation, community design, energy, climate, parks and landscapes and financing and governance. The paper attempts to provide a framework for discussing how best to achieve this goal.

Headings include: How Spatial Planning Affects Inequality, How Does the (NY) Region Measure Up on Indicators of Inequality and Opportunity (with descriptive graphs and performance metrics), and Planning Strategies for Equity and Opportunity.
